Secretary Chen of EOEA Visits Mystic Valley Elder Services' Supportive Living Programs

(Malden, MA)— Secretary Elizabeth Chen, Ph.D., MBA, MPH of the Executive Office of Elder Affairs (EOEA), and other staff members of EOEA recently visited Mystic Valley Elder Services (MVES) to introduce themselves to the model of supportive living/supportive housing programs that MVES operates in Malden and Stoneham and as well as other statefunded supportive housing programs. Secretary Chen met with housing authority staff, Council on Aging and MVES staff members as well as residents of the housing program.

The Supportive Living Program is a partnership between MVES and the public housing authorities and other housing management providers in seven communities including Chelsea, Everett, Malden, Melrose, Revere, Stoneham and Wakefield. The goal of the Supportive Living Program is to provide all residents living in the 23 apartment complexes served by MVES with on-site services that support their independence, safety, enjoyment, and wellbeing. MVES has a coordinator who works at each site to make sure that information and advice is readily available, services fit the needs and desires of the residents in need of in home assistance along with offering a range of social activities and "healthy living" programs to enrich the quality of life for all residents.
